Government Order No: 15 -JK (HP) of 2021 Dated: 05 - 10-2021

Sanction is hereby accorded to the apportionment of the following immovable/movable Assets, Rights and attached Liabilities to the Union Territory of Ladakh:-

A. At JK House, Chanakyapuri, New Delhi

- i) Entire Block-A (comprising of 10 Rooms and 4 Suites);
- ii) Old Block-B (comprising of 14 Rooms and 3 Suites);
- iii) 16 Type-B Staff Quarters; and
- iv) 08 Type-C Staff Quarters.

However, the UT of J&K shall have the right of usage of the third floor of Old Block-B having three suites viz. B-301, B-302 and B-303 till 31st of December, 2021 after which it will stand fully transferred to the UT of Ladakh.

Besides, both the UTs shall use the common entry to the Guest Houses at Chankayapuri, New Delhi till a feasible separate entry is explored, otherwise both the U.Ts will continue to utilize the access through existing entrance.

The Guest Houses/Circuit Houses at Jammu and Srinagar retained by the UT of J&K shall remain available to the officials of the UT of Ladakh whenever required. Besides, all movable assets of the erstwhile State of J&K shall stand apportioned in terms of the Notification No. 339 of 2020 Dated 30.10.2020 issued by the General Administration Department UT of J&K.

Besides, the Additional Resident Commissioner shall be responsible to ensure that titles of the standalone Land/Buildings apportioned to the UT of Ladakh are transferred at an earliest.

All other immovable properties located outside the erstwhile State of J&K and not mentioned specifically shall remain with the UT of J&K.
