The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment *ab-initio* without any further notice.
 - b. Appointee shall furnish an Undertaking in the shape of an Affidavit as per Annexure-A to this Order;
