In continuation to Government Order No. 16-HP(JK) of 2021 dated 24.10.2021, sanction is hereby accorded to the temporary appointment of Shri Irtifa Yousuf S/o Sh. Mohammad Yousuf Khanday R/o Bugam, District Kulgam, as Class-IV/ Watchman, (Divisional Cadre, Kashmir) in the Hospitality and Protocol Department under OM Category, in the Pay Level (SL-1) of (Rs.14800-47100) with immediate effect.

The appointment of the candidate is subject to fulfillment of the following conditions:-

- A. The appointee(s) shall report to the Director, Hospitality and Protocol Department at Srinagar within a period of 21 days from the date of issuance of this order.
- B. The appointee(s) shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-
1. Academic/Technical Qualification Certificates.
 2. Date of Birth Certificate.
 3. Health Certificate issued by Chief Medical Officer.
 4. Domicile Certificate issued by the Competent Authority.
 5. Certificates from the District Industries Center (DIC) and District Employment & Counseling Center to the effect that no loan under any self-employment scheme has been taken by the appointee.
 6. Reserved Category Certificate (in case of candidate belongs to any reserved category).
- C. If upon verification, any certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
- D. If the candidate fails to join within a period of 21(twenty one) days from the date of issuance of this appointment order, he/she shall forego her right to appointment, which shall be deemed to have been cancelled ab-initio without

- any further notice in terms of the Circular No. 08-JK(GAD) of 2019 dated 02.12.2019 issued by General Administration Department.
- E. The appointment of the said candidate shall be governed by the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2020.
- F. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage and she shall be liable for action under Law.
- G. The appointee shall be on probation for a minimum period of 02 years under rules.
- H. The inter-se-seniority of the appointee shall be separately determined by the Director, Hospitality and Protocol Department strictly as per the applicable rules.
- I. The appointment of the said candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009, dated 24.12.2009.
- J. The appointment is subject to the outcome of any writ petition(s) pending before any Court of competent jurisdiction.
