The Terms of Reference of the above committee shall be as under:-

1. The Committee shall monitor and supervise the mission of solarization of all Government Buildings in the Department for accelerated solarization to attain saturation by or before December, 2024 as directed by the Prime Minister's Office (PMO)
2. The Committee shall advice on innovative ways for resource mobilization for successful implementation of the project in RESCO/ Capex/Hybrid modes. They shall suggest source of funding through Finance Department/ NMRE and other Funding Agencies like REC/ other Financial Institutions.
3. The Committee shall recommend decisions regarding the RESCO tender and identification of executing agencies.
4. The Committee shall identify viable buildings and collect all major parameters like availability of rooftop and evacuation network, the total electricity load, sanctioned connected load as well as revenue budget spent on electricity bills be shared with JAKEDA.
5. The Committee shall nominate Estate officers/ In-charge officers for major Buildings where RESCO/ Capex/ Hybrid model shall be implemented.
6. The progress of the Solarization shall be shared on fortnightly basis to the Science and Technology Department/ JAKEDA.
